

**NORTH CHICAGO POLICE DEPARTMENT AGENCY
AGREEMENT**

This agreement made and executed this _____ day of _____ 20____, by _____ of _____ as owner or agent of the owner of the property located at _____ and by officer _____ as agent of the City of North Chicago, Illinois, a Municipal Corporation, provided as follows:

SECTION I-Purpose of Agreement

It is recognized that in certain situations the use of North Chicago police officers to control certain activities on private property located within the corporate limits of the City of North Chicago being conducted by non-residents of the property may be desirable and necessary in order to preserve and protect the health, safety, and welfare of the public.

SECTION II-Power of Authority

- A. I, _____, as owner or agent of the owner of the property listed herein, do hereby authorize and grant the City of North Chicago, as my agent, the power to control non-resident persons who enter and remain upon all property located at _____, North Chicago, IL.
- B. The City of North Chicago specifically has the power to approach persons located on the property and to order them to leave the property and not to return if they are non-residents. The City of North Chicago shall also have the power to cause non-residents to be arrested if they refuse to leave the property. The City of North Chicago, as my agent, shall also have the power to sign criminal complaints against non-residents.
- C. I, _____, as owner of the property or agent thereof, hereby agree that I will cooperate with the city of North Chicago in any criminal prosecutions that may arise from the City of North Chicago's exercise of the authority granted by this agreement.
- D. The City of North Chicago, as agent, does hereby authorize its police officers to control persons entering upon the property located at _____, North Chicago, IL. The police officers are hereby authorized to approach persons located on the property to determine if they reside on the property. Said police officers are empowered to arrest non-residents who refuse to leave or after receiving notice, return without permission of the owner or agent, and said police officers are also empowered to sign criminal complaints against these individuals on behalf of the _____.

SECTION III- Effective Date of Agreement

- A. This agreement shall be in full effect and legally binding upon such time as signed and certified by each party.
- B. The Investigations Division will retain the original signed agreement.

SECTION IV-Termination of Agreement

- A. This agreement shall remain in full force and effect and shall terminate on _____
- B. This agreement is also terminable by either party upon 24 hours notice, in writing, to the other party at the addresses designated below.
- C. If the ownership of the subject property changes during the tendency of this agreement, the original owner shall notify the City of North Chicago Police Department within 24 hours, in writing, of said change in ownership.
